Dear Friends,

NWTRCC just held our November gathering and business meeting in Las Vegas over the weekend of November 6-8. We were hosted by our longtime contact there, Las Vegas Catholic Worker, and joined in various actions and workshops by the staff of the Nevada Desert Experience — a newer contact in the NWTRCC network.

Being together in Las Vegas reminds us how much opportunities for face-to-face discussions about personal war tax resistance or organizing strategy enhance our efforts. Your donations make a big difference toward keeping isolated resisters connected and having the opportunity to come together periodically.

Many of you began war tax resistance because paying for nuclear weapons was a horrific choice. Perhaps an action with Nevada Desert Experience at the Nevada Test Site led you to further resistance. Our Administrative Committee members, Cathy Deppe and Jason Rawn, were in Japan last August for the 70th anniversary commemorations of the bombing of Hiroshima and Nagasaki. They shared what they learned about the extensive U.S. bases in Japan, and Jason went on to Korea where a new base is being built despite local protests and concerns about environmental issues.

In October, the 30th annual New England Gathering of War Tax Resisters and Supporters was held in Amherst, Massachusetts. Over that weekend the group heard from Frida Berrigan, who grew up protesting nuclear weapons and the exploits of the Pentagon and is now especially active with Witness Against Torture in the campaign to close Guantanamo.

Frances Crowe was at the New England Gathering too. By the early 1960s she was active in the antiwar movement because of atmospheric testing. Frances can speak about actions she's been involved in on just about any issue you can think of related to peace, justice, and human rights in the U.S. and around the world.

Our resistance to war and struggle for a better world takes many forms, and through NWTRCC we are connected to an amazing network of activists around the U.S. Some are sharing their reasons for supporting NWTRCC here, even as they also redirect their tax dollars and/or energy to the array of interconnected issues.

During the weekend, besides talking activism and strategy, we also held the Coordinating Committee meeting—the business meeting and highest decision-making body for this organization. Among our decisions was to support a proposal to promote tax season actions that would begin in mid-January, connecting to Martin Luther King Jr. Day if groups choose but it's also the time when the IRS is releasing tax forms and ramping up their demands to file and pay. The goals are twofold: 1) not to wait until tax day to promote war tax resistance, and, 2) to use the time between January and April to work with other groups doing local actions and build relationships for a larger tax day action.

A few groups and individuals have volunteered to act as pilot projects for new ways of outreach and working in coalition locally. Some of those in the room in Las Vegas are connecting with groups like 350.org and climate change issues. Others are working with Black Lives Matter and militarization of the police. Many like the phrase "divest from the Pentagon," because it connects to other types of divestment campaigns. The hope is that by focusing on a few local efforts in the 2016 tax season we can learn from these models and build on that for bigger actions in 2017. But, don't feel left out! If you have a model that you are testing or think will work for others, please share it by sending in a report or idea for our newsletter and website.

And, as always, let us know what you are planning and what you need to enhance your local actions during the coming tax season.

Thanks for all you do and all your support. Your donations really do make a difference in the keeping this network connected and growing.
